

Business Reboot Public Policy Suggestions

Federal

- 1. Extend Paycheck Protection Program (PPP) beyond the current June 30 deadline.
- 2. Reduce PPP requirement on payroll expense to 50% and allow for other expenses such as rent or resupply costs.
- 3. Increase the PPP loan term beyond the current 2-years.
- 4. Eliminate the \$600 additional unemployment compensation payment for those employees who are offered their job back prior the July 31 extension.
- 5. Include "injury" test for EIDL loan applications submitted after June 1, 2020.
- 6. Government to provide a back stop to business interruption insurance as insurance companies have not factored this type of coverage into premiums and forcing them to cover COVID-19 could shift a financial crisis from one business sector to another.
- 7. Provide testing protocols and infrastructure to quickly test employees so that they may appropriately return to the workforce.

State

- 1. Create a balanced approach to provide long-term solvency of the state unemployment system.
- 2. Waive or reduce licensure/permit renewal fees for those expiring during calendar year 2020.
- 3. Increase the amount of community broadband in partnership with private sector providers.
- 4. Provide tax credits for businesses providing work from home solutions for their employees.
- 5. Suspend Commercial Activities Tax collection for bars/restaurants/grocers during calendar year 2020.
- 6. Exempt Personal Protective Equipment (PPE) from sales/use tax for employers.
- 7. Simplification of sales/use tax for manufacturing.
- 8. Repeal sales/use tax on employment services.
- 9. Provide incentives to attract businesses and their supply chain who are involved in the manufacturing of critical infrastructure, as defined by Cybersecurity and Infrastructure Security Agency (CISA) guidelines.

Local

- 1. Tax supported agencies/organization should not seek increases on tax rates unless directly related to life and safety functions.
- 2. Waive/reduce fees associated with electronic payment options for the filing of permits/applications/plans.
- 3. Collaborative purchasing of Personal Protective Equipment (PPE) by local government to better allocate resources and reduce costs and allowing private sector to participate.
- 4. Counties should provide an extension for second half property tax payment and assessments to assist landlords and business with cash flow issues.
- 5. Defer terms for revolving loan funds, job creation grants, or other economic development funding programs. This may include automatically delaying payments, employment quotas, and payroll threshold criteria for recipients.
- 6. Relax signage code enforcement to encourage patronage. This may include allowing certain signage types, sizes, and locations not currently permitted.
- Extend expiration timeframes for building or zoning permits for construction projects that are delayed. This may include automatic extensions for such permits or easing the process for renewing them.
